Bookings / Rules / Surcharges

If there is **more than one wedding** on the day or over the same weekend, the couples may share the cost. The choice of decoration, including <u>colour scheme</u> of the couple who books and pays earliest shall prevail.

The church requires a <u>minimum of **ONE** month's notice with full payment</u> for church wedding flowers.

All floral arrangements are not to be removed from the church premises after the wedding. Please approach the Floral Ministry Coordinator if you have any enquiries.

There will be a **20% surcharge** on floral packages for weddings held during the following period due to the increase in cost of flowers during these times:

- 26th December to 28th/29th February or day before Ash Wednesday whichever is earlier
- Day after Easter to end of May
